The acquisition of new resources discussed was reviewed. Most of the proposed materials were acquired and their positive impact on academic resources was acknowledged.

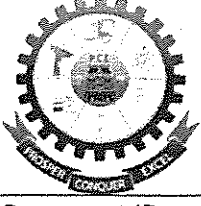
2. Digital Resource Review:
